TERMS & CONDITIONS

- ❖ Program participation is non-transferrable and can be used at any Keystone location.
- ❖ Program participation automatically renews on a month-to-month basis unless it is cancelled with 30 DAYS NOTICE (which must be submitted in writing or via email).
- ❖ Once your cancellation request has been approved you will be relieved from all proceeding monthly program fees.
- ❖ Monthly fees are charged to the specified credit card on file on the 1st or 15th day of each month (chosen by client) and are non-refundable.
- ❖ The monthly fee includes 1 treatment according to the package selected and it is strongly encouraged to be used in the respective program month. Unused credits roll over to the following month.
- ❖ ALL unused treatments will be lost if the program is canceled, or payment is missed.
- ❖ Additional treatments can be purchased at the selected package rate for personal use only. Treatments outside the selected program category can be purchased for personal use by the program participant at a discounted package rate.
- ❖ Other than the chosen monthly fee, there are no hidden sign-up fees, administration fees, or any other fees.
- ❖ Free upgrades earned at the six-month marks of membership must be used within one month of gaining them or else they will be forfeit.
- ❖ Participants are required, per this program agreement, to notify the clinic in writing of any changes to the recurring payment method.
- ❖ Keystone reserves the right to change clinic rules, regulations, and pricing at any time upon providing reasonable notice.
- ❖ You agree to follow clinic rules and regulations. We have the right to refuse or discontinue service if adherence to these rules and regulations is not met. Should that occur, all unused treatments will be lost.
- ❖ You may freeze your program temporarily due to extenuating circumstances, (i.e., extended illness, military leave, temporary relocation) at no cost. For the duration of the freeze period, you may not use program benefits. A freeze must be requested in writing with support documentation. A maximum 4-month freeze is allowed.
